## Trademark Usage Guidelines

ZOLL trademarks are valuable assets that represent ZOLL's brands and help distinguish ZOLL's high-quality products and services from others in the industry. Trademarks, when used correctly, are an important part of a company's branding strategy and provide a legal course of action against others who misuse the company's brands. Below are some basic trademark use guidelines for use with ZOLL's products and services and on product literature, marketing materials, websites, and other written materials.

### **Trademark Use**

The ® registration symbol is universally recognized as an indicator that a brand name (e.g., a word or phrase) is an exclusively owned registered trademark. When used with ZOLL registered trademarks, it puts the public on notice that only ZOLL can use the mark in connection with the relevant products and/or services. The ® registration symbol indicates that ZOLL filed for and has received a trademark grant from a trademark authority (such as the U.S. Patent and Trademark Office), allowing ZOLL exclusive use of the particular mark.

Another symbol used in connection with trademarks is the <sup>™</sup> trademark symbol, which indicates that the mark owner has not been granted a registered trademark from the relevant trademark authority. It is used to put the public on notice that the mark owner either has a trademark application pending, for example in the U.S. Patent and Trademark Office, or that the owner is interested in

merely obtaining non-registered common law rights (recognized in the United States, but not in most other countries).

### General Guidance for Using the ® Symbol

- 1. When generating ZOLL materials for a specific country, the ® symbol should be used immediately following a trademark when the trademark is registered in that country.
- 2. When ZOLL marketing materials are generated by language and may be used in more than one country, as long as the mark is registered in one of the countries in which the materials will be used, the ® symbol may be used in connection with ZOLL trademarks in those materials if the following language is included in the copyright and trademark legend at the end of the content:
  - For ZOLL Medical: "Copyright © [Year] ZOLL Medical Corporation. All rights reserved. [LIST THE USED MARKS] are trademarks or registered trademarks of ZOLL Medical Corporation in the United States and/or other countries. All other trademarks are the property of their respective owners."
  - For subsidiaries of ZOLL Medical: "Copyright © [Year] ZOLL Medical Corporation. All rights reserved. [LIST THE USED MARKS] are trademarks or registered trademarks of ZOLL Medical Corporation and/or its subsidiaries in the United States and/or other countries. All other trademarks are the property of their respective owners."
- 3. When it is not possible to include the above copyright language, such as on product labels, it is acceptable to use the ® symbol when the mark is registered in the U.S. and the product is manufactured in the U.S.
- 4. For other cases, use the ™ symbol.

## Trademark Usage Guidelines - cont.

### **Proper Trademark usage**

- 1. Trademarks are adjectives used to modify nouns; the noun is the generic name of a product or service.
  - Correct: The R Series® defibrillator
  - Incorrect: The R Series® is a defibrillator.
- 2. Since they are adjectives, not nouns, trademarks should not be used in the plural or possessive form:
  - Incorrect: ZOLL AED 3s are available for purchase.
  - Correct: ZOLL AED 3 defibrillators are available for purchase.
  - Incorrect: X Series' biphasic waveform provides optimal defibrillation therapy.
  - Correct: The X Series monitor/defibrillator's biphasic waveform provides optimal defibrillation therapy.

When there are multiple mentions of a registered or unregistered trademark, we recommend marking the first and most prominent use of the mark.

- 3. The generic name of our product (e.g., "defibrillator" or "monitor/defibrillator") should follow the trademark in the first and prominent uses in printed or electronic materials and as often as is reasonable in the balance of the materials. Use the generic term at the first instance of a product name as follows:
  - Acceptable First Use: "R Series monitor/defibrillator" (for example a title of a piece) for flow or due to space constraints.
  - Correct: The R Series monitor/defibrillator is used by hospitals to treat patients suffering from cardiac arrest.
- 4. In text following a title and/or prominent use of the mark, although not preferred but in order to avoid repetition and for readability of marketing materials, the mark may sometimes be used without a following generic noun and/or without the trademark symbol ®. In those instances, however, avoid using an article but rather use as a name:
  - Acceptable: R Series® is a monitor/defibrillator.
  - Acceptable: R Series® has easy-to-use technologies to help you consistently deliver high-quality CPR.
  - Incorrect: The X Series® addresses EMS needs now and moving forward.
  - Incorrect: What is the X Series®?
  - Incorrect: The X Series® provides defibrillation and real-time CPR feedback in one compact device.
- 5. When referring to the company, always capitalize every letter of "ZOLL."
  - Correct: ZOLL develops and manufactures industry-leading products.
  - Incorrect: Zoll develops and manufactures industry-leading products.

The following are proper usages of ZOLL-related names and products. These guidelines should help increase quality and consistency in all company materials and correspondence.

Do not use individual product logos, bold, italics, or type treatments such as dots in our product names.

All materials should include a copyright line that identifies ZOLL and any other products mentioned as registered trademarks. Please refer to **Section 5: Trademark Usage Guidelines** for guidance on when and how to use register marks and the language and formatting for copyright lines.
